PT Adhi Karya (Persero) Tbk (ADHI)

BUY ON WEAKNESS (456 – 470)
Target Price 488 – 500 – 525
Stoploss < 438

Pada perdagangan 11 Oktober ditutup pada level 478 menguat +3.02%.

Secara teknikal, ADHI break swing high downtrend minor, berada diatas EMA 10 dan EMA 20. Indikator StochRSI dan MACD menunjukkan penguatan.



PT Bumi Serpong Damai Tbk (BSDE)

BUY (1045 – 1085)
Target Price 1105 – 1135 – 1160
Stoploss < 1000

Pada perdagangan 11 Oktober ditutup pada level 1085 menguat +3.83%.

Secara teknikal, BSDE breakout pola cup and handle, serta breakout EMA 10, 20, dan 200. Indikator StochRSI dan MACD menunjukkan penguatan.



PT PP Presisi Tbk (PPRE)

BUY ON WEAKNESS (96 – 100)
Target Price 105 – 110 – 115
Stoploss < 94

Pada perdagangan 11 Oktober ditutup pada level 101 menguat +3.06%.

Secara teknikal, PPRE berada di area support horizontal, berada diatas EMA 10 dan EMA 20 kembali. Indikator StochRSI dan MACD menunjukkan potensi penguatan.



PT Trans Power Marine Tbk (TPMA)

BUY ON BREAKOUT (765)
Target Price 800 – 860
Stoploss < 715

Pada perdagangan 11 Oktober ditutup pada level 750 menguat +11.94%.

Secara teknikal, TPMA breakout pola cup and handle dan rebound dari EMA 10 dan EMA 20. Indikator StochRSI dan MACD menunjukkan penguatan.
