Pada perdagangan Senin, 2 Juni 2025, IHSG ditutup pada level 7.065,07 melemah -1,54%. Transaksi IHSG sebesar Rp22,237 T serta asing mencatatkan net sell sebesar Rp2,81 T di All Market.

IHSG melemah disebabkan oleh minimnya sentimen dan diwarnai oleh aksi taking profit investor asing dan domestik. Data PMI Manufaktur Indonesia di bulan Mei diperkirakan menunjukkan kontraksi, sentimen negatif karena menandakan perekonomian Indonesia melambat. Indeks Harga Konsumen Indonesia juga diperkirakan mengalami deflasi kembali.

Pada perdagangan Selasa, 3 Juni 2025, IHSG diprediksi bergerak pada rentang 6.950 – 7.050. Saham – saham yang dapat diperhatikan seperti **RALS, BANK, dan WIFI**.

Secara teknikal, RALS berpotensi kembali uptrend jangka pendek setelah rebound dari support horizontal dan EMA 200.

Indikator StochRSI dan MACD potensi kembali menguat.



PT Bank Aladin Syariah Tbk (BANK)

BUY ON BREAKOUT (880)

Target Price 910 – 980 – 1065

Stoploss < 815

Secara teknikal, BANK memasuki fase sideways setelah downtrend jangka panjang. Sudah breakout dari EMA 200, jika breakout resisten sudah valid uptrend karena double bottom, pola reversal.

Indikator StochRSI dan MACD kembali menguat.

BUY (1950 – 2080)
Target Price 2150 – 2300 – 2420
Stoploss < 1920

Secara Teknikal, WIFI tertahan oleh support dinamis EMA 20 dan EMA 50, support horizontal, dan telah menutupi gap up .
Indikator StochRSI dan MACD menguat.
