Pada perdagangan Kamis, 5 Juni 2025, IHSG ditutup pada level 7.113,42 menguat +0,63%. Transaksi IHSG sebesar Rp16,411 T serta asing mencatatkan net sell sebesar Rp720 M di All Market.

Penguatan di hari Kamis ditopang oleh peningkatan besar dari saham-saham grup Konglomerat Prajogo Pengestu. Selama seminggu terakhir, IHSG bergerak cenderung koreksi disebabkan oleh Investor sedang berjaga-jaga menunggu data ekonomi Indonesia dan Amerika Serikat. Diprediksi IHSG cenderung bergerak koreksi karena investor akan taking profit dan berjaga-jaga terhadap konflik panas antara Presiden AS Donald Trump dengan Elon Musk yang potensi mengguncang pasar saham global. Pada perdagangan Selasa, 10 Juni 2025, IHSG diprediksi bergerak pada rentang 7.100 – 7.170. Saham – saham yang dapat diperhatikan seperti **PANI, JKON, dan PRDA**.

Stoploss < 10.600

Secara teknikal, PANI berpotensi kembali uptrend jangka pendek karena indikator mulai menguat tetapi tertahan oleh resisten dinamis EMA 20 dan EMA 50.

Indikator StochRSI dan MACD mulai menguat.



PT Jaya Konstruksi Manggala Pratama Tbk (JKON)

BUY ON WEAKNESS (71 – 74)

Target Price 79 – 85 – 90

Stoploss < 70

Secara teknikal, JKON potensi kembali uptrend setelah rebound dari EMA 20 dan EMA 50.

Indikator StochRSI dan MACD kembali menguat.

(PRDA)**

BUY ON WEAKNESS (2730 – 2780)

Target Price 2860 – 2920 – 3000 – 3100

Stoploss < 2700

Secara Teknikal, PRDA berpotensi menguat membentuk pola rounding bullish. Jika breakout EMA 200, PRDA valid uptrend jangka menengah. Indikator StochRSI dan MACD kembali menguat.
