Pada perdagangan Rabu 23 Juli 2025, IHSG ditutup pada level 7.469,23 menguat +1,70%. Transaksi IHSG sebesar Rp15,89 T serta asing mencatatkan net buy sebesar Rp663 Miliar di All Market.

Pasar bergerak menguat ditopang oleh kenaikan tinggi dari saham DCII dan PANI yang memiliki kapitalisasi pasar yang besar. Asing mulai koleksi saham-saham bluechip seperti ASII, TLKM, hingga UNTR. M2 Supply Juni 2025 menunjukkan nilai tertingginya, dapat memberikan sentimen positif terhadap pasar saham jika ditambah dengan penurunan suku bunga.

Pada perdagangan Kamis 24 Juli 2025, IHSG diprediksi bergerak pada rentang 7.400 – 7.520. Saham – saham yang dapat diperhatikan seperti **AKRA, AMMN, dan BSDE**.

Indikator MACD berpotensi menguat dan golden cross.
