Pasar bergerak menguat akibat dari optimisme investor setelah Chairman the Fed Jerome Powell memberikan sinyal pemangkasan suku bunga. Pasar saham Regional Amerika Serikat terbang diikuti oleh pasar saham Indonesia karena memberikan potensi aliran dana dari AS yang dapat membuat IHSG serta Rupiah dapat menguat.

Pada perdagangan Selasa 26 Agustus 2025, IHSG diprediksi bergerak pada rentang 7.850 – 7.950. Saham – saham yang dapat diperhatikan seperti **AKRA, ARCI, dan DKFT**.
