Pada perdagangan Rabu 10 September 2025, IHSG ditutup pada level 7.699,01 menguat +0,92%. Transaksi IHSG sebesar Rp15,67 T serta asing mencatatkan net sell sebesar Rp574 Miliar di All Market. Pasar saham bergerak didorong oleh sektor keuangan yang naik hingga +1,33%. Kenaikan ini diduga hanya sebagai respon rebound sementara setelah koreksi tajam sampai 4% dalam 2 hari dari titik tertinginya. Investor masih waspada terhadap pergerakan IHSG karena transaksi cukup kecil dan rawan hanya terjadi dead cat bounce.

Pada perdagangan Kamis 11 September 2025, IHSG diprediksi bergerak pada rentang 7.550 – 7.750. Saham – saham yang dapat diperhatikan seperti **RAAM, BSSR, dan MIDI**.

Target Price 3970 – 4020 – 4100 – 4180 – 4300

Stoploss < 3800

Secara teknikal, BSSR dalam fase sideways di area support horizontal swing low. Berpotensi uptrend jika breakout pola triple bottom. Indikator MACD melemah dan death cross.
