Pasar saham bergerak menguat didorong oleh optimisme pelaku pasar terhadap aksi Menteri Keuangan, Purbaya Yudhi Sadewa yang melakukan dialog dengan Petinggi Pasar Modal di Bursa Efek Indonesia. Hal ini memberikan angin segar akan terjadinya perubahan yang lebih baik dalam iklim investasi di Indonesia. Saham Big 4 Banks terbang seketika dipimpin oleh BBRI.

Pada perdagangan Jumat 10 Oktober 2025, IHSG diprediksi bergerak pada rentang 8.150 – 8.320. Saham – saham yang dapat diperhatikan seperti **AMMN, UNVR, dan TUGU**.

Indikator MACD kembali menguat dan golden cross.

BUY ON WEAKNESS (1815 – 1900)

Target Price 2000 – 2170 – 2300 – 2450

Stoploss < 1780

Secara teknikal, UNVR dalam fase ascending triangle sekaligus pola VCP, berada diatas MA 5, MA 50, dan MA 200, sinyal bullish.

Indikator MACD kembali menguat.
