Pada perdagangan Senin 20 Oktober 2025, IHSG ditutup pada level 8.088,98 menguat +2,19%. Transaksi IHSG sebesar Rp22,86 T serta asing mencatatkan net buy sebesar Rp533 Miliar di All Market. Pasar saham bergerak menguat didorong oleh kenaikan masif dari Saham Bluechip seperti Big 4 Banks, UNVR, hingga rebound saham konglomerasi. Kenaikan perbankan ditengarai karena aksi beli investor mengingat dividen besar yang ditawarkan oleh emiten. Rencana aksi buyback oleh Bank BCA menjadi tambahan kepercayaan investor terhadap saham bluechip.

Pada perdagangan Selasa 21 Oktober 2025, IHSG diprediksi bergerak pada rentang 7.850 – 8.150. Saham – saham yang dapat diperhatikan seperti **INDY, SMGR, dan JKON**.
