Pada perdagangan Selasa 21 Oktober 2025, IHSG ditutup pada level 8.238,08 menguat +1,84%. Transaksi IHSG sebesar Rp22,05 T serta asing mencatatkan net buy sebesar Rp1,34 Triliun di All Market. Pasar saham bergerak menguat didorong oleh rally saham bluechip. Hal ini ditengarai oleh aksi buyback dari dana asing yang masif setelah 2 bulan melakukan outflow. BBKA dengan aksi net buy asing terbesar hingga Rp1,3 Triliun merangkak hingga +7,6%, hal ini mendorong IHSG mendekati titik tertinggi sepanjang masa. Aksi net buy asing masif dalam 2 hari terakhir memberikan sinyal IHSG akan bullish sampai akhir tahun.

Pada perdagangan Rabu 22 Oktober 2025, IHSG diprediksi bergerak pada rentang 8.100 – 8.280. Saham – saham yang dapat diperhatikan seperti **CTRA**, **MNCN**, dan **BSSR**.

Target Price 282 – 288 – 300 – 312

Stoploss < 254

Secara teknikal, MNCN berpotensi uptrend major, rebound dan breakout dari MA 50 dan MA 200, serta berpotensi breakout pola double bottom.

Indikator MACD kembali menguat dan berpotensi golden cross.

Stoploss < 3800

Secara Teknikal, BSSR rebound dari support horizontal serta berpotensi breakout double bottom.
