Pada perdagangan Kamis 30 Oktober 2025, IHSG ditutup pada level 8.184,06 menguat +0,22%. Transaksi IHSG sebesar Rp21,81 T serta investor asing mencatatkan net beli sebesar Rp945 Miliar di Reguler Market.

Pasar saham bergerak menguat di awal hari ditengarai optimisme pasar setelah The Fed menurunkan suku bunga sebanyak 25 bps ke level 4%. Hal ini membuat emerging market memiliki potensi inflow dari fund manager global, saham bluechip menjadi pilihan investasi yang lebih potensial dibandingkan obligasi negara.

Pada perdagangan Jumat 31 Oktober 2025, IHSG diprediksi bergerak pada rentang 8.040 – 8.260. Saham – saham yang dapat diperhatikan seperti **ADHI, BMTR, dan CLEO**.

BUY ON BREAKOUT (148)
Target Price 155 – 161 – 168
Stoploss < 142

Secara teknikal, BMTR dalam potensi uptrend setelah membentuk higher high, berada di area support horizontal dan tertahan MA 200.
Indikator MACD kembali menguat dan berpotensi golden cross.



**PT Sariguna Primatirta Tbk
(CLEO)**
BUY ON BREAKOUT (550)
Target Price 575 – 600 – 620
Stoploss < 525

Secara Teknikal, CLEO dalam fase sideways setelah downtrend, rebound dari MA 10 dan berpotensi menguat jika breakout MA 60 dan pola cup and handle.

Indikator MACD dalam fase menguat.
