Pada perdagangan Kamis 20 November 2025, IHSG ditutup pada level 8.419,92 menguat +0,16%. Transaksi IHSG sebesar Rp19,65 T serta investor asing mencatatkan beli bersih sebesar Rp1,09 Triliun di Pasar Reguler.

Pasar saham bergerak menguat ditengarai dari aksi BI mempertahankan suku bunga yang sesuai ekspektasi untuk menjaga nilai Rupiah serta Inflasi. Investor asing memborong saham Indonesia merespon dari hasil laporan keuangan Nvidia yang diatas ekspektasi, memberikan ruang bagi pasar untuk terus bertumbuh ditengah kekhawatiran market crash.

Pada perdagangan Jumat 21 November 2025, IHSG diprediksi bergerak pada rentang 8.180 - 8.400. Saham – saham yang dapat diperhatikan seperti **DILD, CLEO, dan RAAM**.

Indikator MACD dalam fase penguatan.



PT Sariguna Primatirta Tbk (CLEO)

BUY ON WEAKNESS (484 – 510)

Target Price 545 – 585 – 615

Stoploss < 478

Secara teknikal, CLEO berada didalam area support horizontal dan berpotensi menguat setelah memasuki fase sideways.

Indikator MACD dalam fase pelemahan.
