Pada perdagangan Kamis 27 November 2025, IHSG ditutup pada level 8.545,86 melemah -0,65%. Transaksi IHSG sebesar Rp27,69 T serta investor asing mencatatkan jual bersih sebesar Rp884 Miliar di Pasar Reguler.

Pasar saham bergerak melemah ditengarai akibat dari aksi taking profit dari pelaku pasar khususnya investor asing. Aksi waspada pelaku pasar untuk menunggu serangkaian data penting di minggu depan untuk menentukan apakah terjadi window dressing atau tidak.

Pada perdagangan Jumat 28 November 2025, IHSG diprediksi bergerak pada rentang 8.400 – 8.625. Saham – saham yang dapat diperhatikan seperti **TBIG, SMBR, dan CBRE**.

Target Price 2100 – 2160 – 2230 – 2380

Stoploss < 1920

Secara teknikal, TBIG berpotensi uptrend kembali jika breakout dari pola reversal double bottom serta MA 10 dan MA 200, berada di area support horizontal.

Indikator MACD menguat dan berpotensi golden cross.



PT Semen Baturaja Tbk (SMBR)

BUY ON WEAKNESS (280 – 288)

Target Price 300 – 310 – 320 – 330

Stoploss < 276

Secara teknikal, SMBR berpotensi uptrend setelah breakout bullish flag serta berpotensi membentuk pola inverted head and shoulders, rebound dari MA 60.

Indikator MACD menguat dan golden cross.

Secara teknikal, CBRE rebound dari MA 60 dan tertahan MA 10, berpotensi uptrend jangka pendek jika breakout MA 10, resisten horizontal, sekaligus pola falling wedge.

Indikator MACD menguat dan berpotensi golden cross.
