Pada perdagangan Senin 19 Januari 2026, IHSG ditutup pada level 9.133,87 menguat +0,64%. Transaksi IHSG sebesar Rp35,92 T serta investor asing mencatatkan jual bersih sebesar Rp542 Miliar di Pasar Reguler.

Pasar saham bergerak menguat didorong oleh penguatan lanjutan dari sektor tekstil dan *waste to energy* karena sentimen Proyek Danantara, rebound dari emiten konglomerasi Barito, hingga peningkatan tipis saham *big banks*. Perilaku investasi pelaku pasar terjadi *shifting* ke emiten dengan valuasi yang *undervalue* serta memiliki dividen *yield* tinggi sebagai *rebalancing* portofolio di saat IHSG terus mencetak *all time high*.

Pada perdagangan Selasa 20 Januari 2026, IHSG diprediksi bergerak pada rentang 9.000 – 9.200. Saham – saham yang dapat diperhatikan seperti **LPPF, BWPT, dan SPTO**.

Secara teknikal, LPPF berpotensi uptrend jangka menengah setelah breakout pola inverted head and shoulders.

Indikator MACD kembali menguat.

BUY ON WEAKNESS (148 – 157)

Target Price 168 – 175 – 183

Stoploss < 139

Secara teknikal, BWPT dalam fase uptrend setelah breakout dari pola double bottom dan rebound dari support uptrend.

Indikator MACD kembali menguat.
