Pada perdagangan Kamis 12 Maret 2026, IHSG ditutup pada level 7.362,12 melemah -0,37%. Transaksi IHSG sebesar Rp13,38 T serta investor asing mencatatkan beli bersih sebesar Rp905 Miliar di Pasar Reguler.

Pasar saham dibuka bergerak volatil dengan ditutup melemah. Transaksi pelaku pasar cenderung rendah disebabkan aksi menunggu selesai libur panjang serta berjaga-jaga akibat dari meningkatnya ketegangan geopolitik di Timur Tengah. Aksi menunggu kebijakan suku bunga the fed menjadi salah satu sentimen sepiunya transaksi pasar.

Pada perdagangan Jumat 13 Maret 2026, IHSG diprediksi bergerak pada rentang 7.240 – 7.590. Saham – saham yang dapat diperhatikan seperti **BMRI, SMDR, dan SSIA**.

Target Price 380 – 394 – 418 – 448
Stoploss < 336

Secara teknikal, SMDR dalam area support pola uptrend serta support dinamis MA 200, berpotensi menguat jika membentuk pola morning star.
 Indikator MACD dalam fase pelemahan.



PT Surya Semesta Internusa Tbk (SSIA)
BUY ON BREAKOUT (1225)
Target Price 1300 – 1385 – 1460
Stoploss < 1125

Secara teknikal, SSIA dalam fase downtrend dan rebound dari support horizontal sekaligus support pola downtrend. Indikator MACD menguat dan potensi golden cross.
